Madame Talar Faiq took up her role as the Director at Erbil International Airport in August 2010, having joined EIA as Deputy Director in late 2009. Under her leadership the new international airport opened in September 2010 and saw a successful first year of operation with new airlines, cargo carriers and a 39 per cent increase in passenger numbers to 555,714 in the 12 months since 1 September, 2010. The airport continues to grow and has emerged as one of the fastest growing in the Middle East, with traffic up 61 per cent in the first 8 months of 2012 and cargo tonnage plus 67 per cent.

Her contribution was recognised in June 2011 when she was awarded, 'Best Woman in Aviation' at the Emerging Markets Airport Awards, in Dubai.

The Director General is married with one daughter, has devoted her professional career to helping her fellow Kurds and to serving the Kurdistan Regional Government in a variety of roles either in Iraq and her native Kurdistan or in Europe and the UK.

Her career began in travel as an IATA accredited manager in Sullimanyah before she joined the United Nations High Commission for Refugees (UNHCR) where she played a key role in assisting the humanitarian effort to relieve the effects of sanctions. Salih was a key member of the local staff and stayed with the UN in a variety of key positions for nearly ten years before moving to the UK to support the growing Kurdish community there. In 2002, Madame Talar was nominated and assumed the role of 'Ambassador for Peace' at the UN linked International Inter-Religious Federation for World Peace, (IIFWP) in London. From her base in the West Midlands of the UK and the growing Kurdish community there she made her move to London where she took up a role at the International Organisation for Migration (IOM) in 2006.

In 2008, Ms Faiq joined the office of the Kurdistan Regional Government mission to the UK capital. Taking up a role as a senior member of the mission she worked with senior officials of the KRG to liaise with the UK Government and members of Parliament.

Ms Faiq is an accomplished administrator and manager, who has played an important role in supporting the KRG as it, and the region, has emerged from the aftermath of dictatorship in 2003. It is these skills that are brought to bear to deliver her vision, and that of the KRG, to create for the Kurdish people and region, a modern, 21st century centre of excellence at Erbil International Airport.

In her leadership role as Airport Director, Madame Talar has overseen considerable expansion and growth and well as countering the operational and other challenges associated with the current crisis in Iraq. Recently she oversaw the completion of a major new master plan for Erbil International Airport, and hopes in the near future to begin implementation despite the constraints facing Kurdistan.

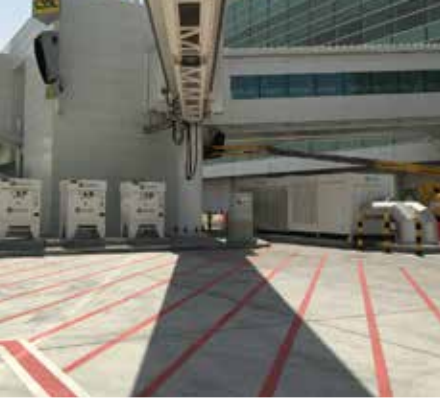

Emerging markets always provide a host of challenges that differ from those that can be found in the more mature markets of Western Europe and North America.

And it is true to say that aviation in Iraq brings with it a set of unique challenges that even the other emerging markets of South America, Africa and parts of Asia will find truly difficult to replicate, were that is, they were ever minded to do so.

Security threats posed by ISIS, a national carrier that fails to pay airport charges or pass on passenger taxes, expecting host airports, somehow, to miraculously maintain infrastructure and provide facilities, and a regulator in the ICAA that is in urgent need of reform and modernization.

That said, the aviation market in Iraq continues to show signs of life - Fly Baghdad, Al Nasser, Zagros are just some of the entrants to the lucrative domestic market, alongside the ever present Iraqi Airways.

In August 2014, ISIS came within 40 km of Erbil, throughout the hiatus that followed, and the commencement of coalition air operations against the self declared 'caliphate', Erbil International Airport has remained open, and as of November, 2015, continues to operate, nearing capacity on some days.

Erbil International Airport was commissioned in 2004 by the then Prime Minister Nechirvan Barzani, the \$365m airport opened to traffic in September, 2010.

The growth of passenger and cargo traffic at the airport since civilian traffic commenced at Erbil in 2005 has averaged 30%. It is the hiatus of ISIS, the sanctions places on freight movements by the former Maliki government and the on-going financial crisis driven by the Erbil/ Baghdad budget dispute that have caused such growth to pause. Security concerns caused many airlines to suspend operations in 2014 and in March 2015, but now, all airlines, except Etihad have resumed.

In 2012, Director General Talar Faiq, commissioned a new long term plan for the airport. Undertaken by Lufthansa Consulting, the new plans allows for both terminal and cargo expansion and commercial expansion to attract investment and drive growth. The implementation of such plans await a more benign and stable investment environment but if conditions allow, and building on security and stability in the region, Erbil International Airport can be a gateway for growth, trade and prosperity across Northern Iraq and the country as a whole.

Whilst more mature airport markets focus on battles to build new runways and enhance their environmental credentials, as an emerging market airport, Erbil International will focus on enhancing safe and secure operation, to maintain facilities as best it can, in a challenging financial climate and look forward to better times ahead, as a gateway for a prospering region and, we hope, peaceful region and country.

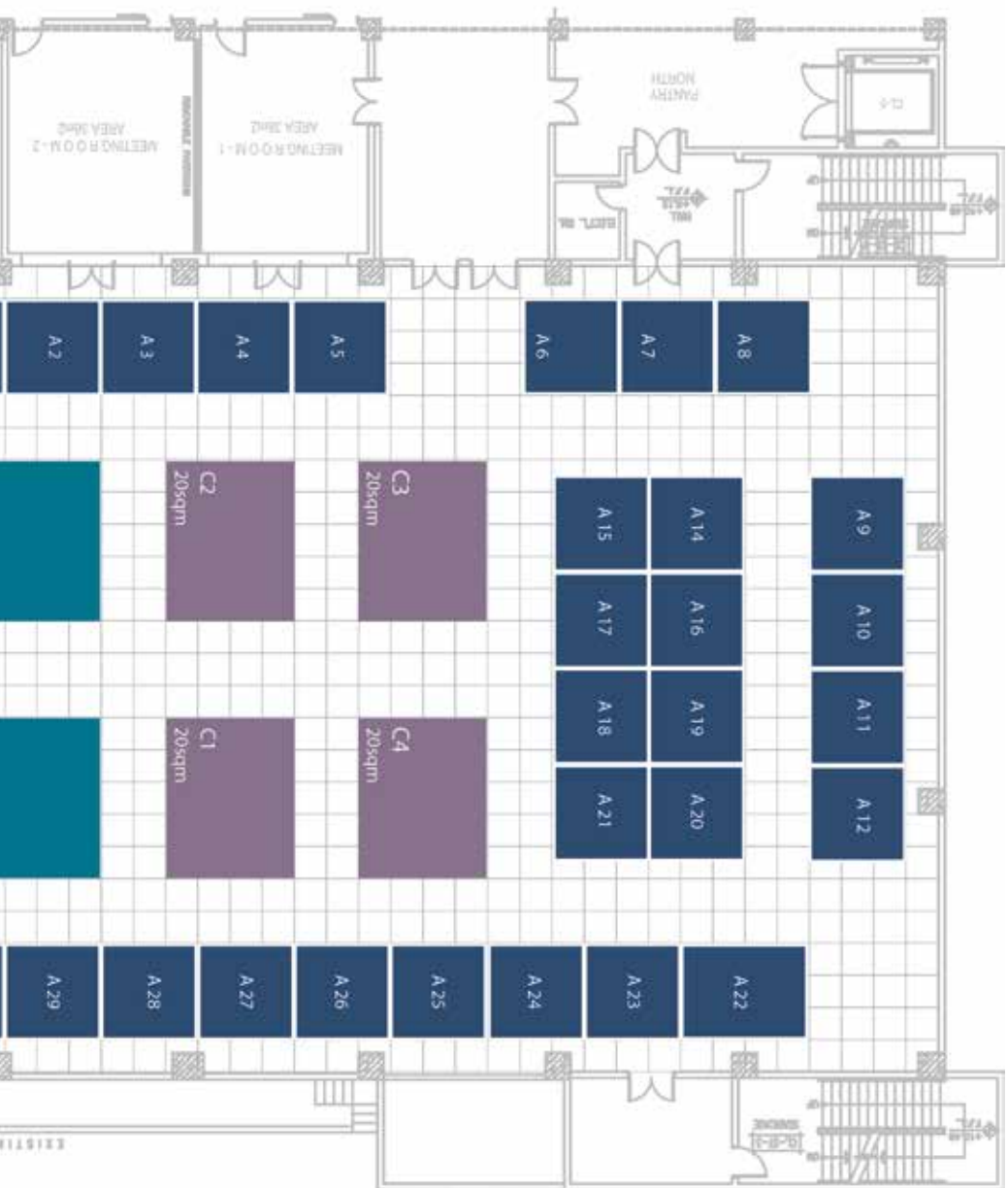
